**APPROVING MUNICIPAL RESOLUTION NO. 46, S-2018 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PLAN (AIP) FOR CALENDAR YEAR 2019 OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Resolution No. 46, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same Local Development Council of San Nicolas, Pangasinan has formulated the municipality's Annual Investment Program for CY 2019 and endorsed thru MDC Resolution No. 01, CY 2018 dated August 31, 2018 to the Sangguniang Bayan for approval. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 46, S-2018 dated September 24, 2018. This is in consonance to Sections 106, 109 and 114 of RA 7160;
