PROVINCIAL RESOLUTION NO. 279-2022

STRONGLY EXPRESSING THE SENTIMENT OF THE SANGGUNIANG PANLALAWIGAN IN MAINTAINING THE STATUS QUO REGARDING THE NON-OPERATION OF SMALL TOWN LOTTERY IN THE PROVINCE OF PANGASINAN

WHEREAS, Letter Circular No. 2022-0028 of the Office of the Governor, dated February 18, 2022, informed all Local Chief Executives in the Province of Pangasinan that there are reports circulating around the Province regarding an alleged new STL operator approved by the Philippine Charity Sweepstakes Office (PCSO);

WHEREAS, as of date, the Provincial Government has not yet received any official communication from the PCSO as to any approved Authorized Agency Corporation (AAC) which will operate STL in the Province;

WHEREAS, the Sangguniang Panlalawigan is concerned that an STL operation in Pangasinan may create chaotic incidences as it has already been experiencing peace and order sans the operation of STL in Pangasinan;

WHEREAS, it is the desire of the Sangguniang Panlalawigan that the pending case between PCSO and Globaltech Mobile Online Corporation be resolved first before any STL operator is allowed to operate in the Province in order to avoid embroilment;

WHEREAS, the Sangguniang Panlalawigan supports the call of the Provincial Governor in aforesaid circular for LGUs to be vigilant in implementing pertinent laws in allowing operation of STL in their respective jurisdiction;

WHEREFORE, in view of the foregoing, on motion of SP Member Nestor D. Reyes, duly seconded, it was –


