#### **PROVINCIAL RESOLUTION NO. 280-2021**

AUTHORIZING THE PROVINCIAL GOVERNOR AND THE PROVINCIAL TREASURER TO OPEN A NEW ACCOUNT WITH THE LAND BANK OF THE PHILIPPINES FOR THE MAINTENANCE OF A SEPARATE ACCOUNT FOR PROFESSIONAL FEE OF MAPANDAN COMMUNITY HOSPITAL

WHEREAS, in pursuance to PHO Memorandum Order No. 20-11-506 dated November 25, 2020, the Provincial Health Office Audit Team, led by Dr. Anna Ma. Teresa S. de Guzman, Provincial Health Officer, has directed the provincial government hospitals to reconcile their income, remittances and bank accounts at the Provincial Accounting Office and Provincial Treasurer's Office;

**WHEREAS,** one of the findings of the audit is for the Mapandan Community Hospital to maintain a separate account for Professional Fee;

**WHEREAS,** at present, the Mapandan Community Hospital does not have a separate account for Professional Fee and its collections are deposited in the same account for Drugs and Medicines but under a separate professional fee deposit slip for accounting and/or monitoring purposes;

**WHEREAS,** there is a need therefore, to open a new account for Professional Fee with bank name: Province of Pangasinan for the Account of Mapandan Community Hospital;

**NOW, THEREFORE**, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan of Pangasinan in session assembled to authorize, as they are hereby authorized, the Provincial Governor and the Provincial Treasurer to open a new account with the Land Bank of the Philippines for the maintenance of a separate account for professional fee of Mapandan Community Hospital;
