#### **RESOLUTION NO. 287-2021**

DECLARING MUNICIPAL ORDINANCE NO. 02, S-2021 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE USE OF ACCESS DEVICES FOR PAYMENT OF FEES, CHARGES, ASSESSMENTS AND OTHER REVENUES DUE TO THE MUNICIPALITY OF BAYAMBANG THROUGH THE ELECTRONIC PAYMENT AND COLLECTION SYSTEM (EPCS)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Municipal Ordinance No. 02, Series of 2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 27 of Republic Act No. 8792, otherwise known as the "Electronic Commerce Act of 2000" and Section 37 of its Implementing Rules and Regulations; DTI-DOF Joint Administrative Order No. 2, Series of 2006 prescribing the "Guidelines Implementing RA 8792 on Electronic Payment and Collection System in Government";

WHEREAS, subject ordinance shall take effect after compliance with the requirement on law of posting pursuant to Section 59 of RA 7160;
