PROVINCIAL RESOLUTION NO. 3-2022

AUTHORIZING THE LAND BANK OF THE PHILIPPINES-URDANETA BRANCH TO REACTIVATE A DORMANT ACCOUNT OF THE PROVINCIAL GOVERNMENT OF PANGASINAN AND FURTHER AUTHORIZING THE PROVINCIAL GOVERNOR AND THE PROVINCIAL TREASURER TO EXECUTE AND SIGN DOCUMENTS PERTAINING THERETO

WHEREAS, LANDBANK records show that a deposit account under the name of the Provincial Government of Pangasinan has been classified as “Dormant” status;

WHEREAS, the Provincial Government of Pangasinan still needs to maintain the said account for its financial transactions;

WHEREAS, it is necessary therefore, to request the reactivation of Account No. 0112-1151-96 (Provincial Government of Pangasinan-Pangasinan Credit Surety Administrative Fund);

WHEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as it is hereby authorized, the Land Bank of the Philippines-Urdaneta Branch to reactivate a dormant account of the Provincial Government of Pangasinan and further authorizing the Provincial Governor and the Provincial Treasurer to execute and sign documents pertaining thereto;
