APPROVING RESOLUTION NO. 181, S-2019-22 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED ‘APPROVING THE SUPPLEMENTAL INVESTMENT PLAN OF THE CITY OF URDANETA FOR CY 2020 IN THE AMOUNT OF SIXTY-EIGHT MILLION ONE HUNDRED FIFTY-SEVEN THOUSAND TWO HUNDRED TWENTY-FOUR PESOS ONLY (P68,157,224.00) REPRESENTING THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (LBC 125)’

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Resolution No. 181, Series of 2019-22 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Urdaneta City, Pangasinan has adopted and endorsed the city’s Supplemental Annual Investment Program No. 2 thru CDC Resolution No. 2-2020 dated March 4, 2020 to the Sangguniang Panlungsod for approval. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 02 of the city has an investment requirement amounting to P68,157,224.00 to be funded by Supplemental Budget No. 2 enacted through Appropriation Ordinance No. 6, S-2019-22 (P51,157,224.00) and LDRRMF Trust Fund (P17,000,000.00);

WHEREAS, for the projects to be funded by the Trust Fund (P17,000,000.00), a revised AIP must be prepared by the LGU as provided in Item 2.5.6 of Local Budget Circular No. 124 dated March 26, 2020 and Item 6.5 of COA Circular No. 2012-002 and NDRRMC-DBM-DILG JMC No. 2013-01 dated March 25, 2013;


