APPROVING RESOLUTION NO. 19(A)-089 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “REALIGNING THE AMOUNT OF THREE HUNDRED THOUSAND PESOS (P300,000.00) FROM THE (P650,649.00) FUNDING OF PROJECT TITLED: PROCUREMENT OF MEDICAL SUPPLIES, MEDICINES AND EQUIPMENT TO: PROJECT TITLED: CONDUCT OF SEMINARS AND DRILLS IN THE AMOUNT OF THREE HUNDRED THOUSAND PESOS (P300,000.00)”

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 19(A)-089 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos City, Pangasinan has proposed for the realignment of the sum of P300,000.00 from the project “Procurement of Medical Supplies, Medicines and Equipment” to augment funds for the project “Conduct of Seminars and Drills”. This was endorsed thru CDC Resolution No. 15-19 dated December 11, 2019 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 19(A)-089 dated December 16, 2019;

WHEREAS, both of the aforementioned projects/activities are included in the 2019 AIP/LDRRM Plan of the LGU. The reason for the realignment is to provide additional funding for the project/activity “Conduct of Seminars and Drills”, a priority of the LGU to enhance the capabilities of the CDRRMO personnel. Also, part of the activities to be funded under the project “Procurement of Medical Supplies, Medicines and Equipment”, are already completed in other projects and are already implemented, hence, no longer utilizable as stated in the CDC Resolution;

WHEREAS, the proposed realignment is supported by CDRRM Council Resolution No. 001-2019 dated December 9, 2019;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
