APPROVING RESOLUTION NO. 98-2020 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 CY 2020 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Resolution No. 98-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said municipal resolution and found out that the Municipal Development Council of San Jacinto, Pangasinan has prepared the municipality's Supplemental Investment Program No. 4 for CY 2020. This was endorsed by the Council, through MDC Resolution No. 2020-6 dated December 22, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 98-2020 dated December 22, 2020;

WHEREAS, said Supplemental Annual Investment Program, which has a total investment requirement of P706,000.00, covers the granting of Service Recognition Incentive (SRI) to qualified personnel of the LGU;

WHEREAS, funding for the Supplemental AIP is embodied in the Supplemental Budget No. 4, CY 2020, and enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2020-05, Series of 2020 dated December 22, 2020;
