#### **PROVINCIAL RESOLUTION NO. 304-2019**

AMENDING THE SUBMITTED LISTS OF RECIPIENTS FOR OPEN WELL AND SHALLOW TUBE WELL IRRIGATION PROJECT (DRILLED) INCLUDING THE REHABILITATION AND CONSTRUCTION OF COMMUNAL IRRIGATION SYSTEM AND PROJECTS PER MUNICIPALITY IN THE PROVINCE OF PANGASINAN UNDER TERM LOAN 28

WHEREAS, the Provincial Government of Pangasinan and the Land Bank of the Philippines entered into an Omnibus Term Loan Facility Sub-Loan Agreement on March 21, 2019 for Term Loans 27, 28, 29, 30, 31 and 32 amounting to Nine Hundred Million Pesos only (P900,000,000.00);

WHEREAS, loan proceeds under Term Loan 28 will be utilized to finance the constructions/rehabilitation of communal, pump, impounding, dam, open well and shallow tube well irrigation system amounting to P50 Million;

WHEREAS, after thorough conduct of site inspection and evaluation of the submitted list under Provincial Ordinance No. 227-2019, it was found out that some areas for communal irrigation are not accessible and drilling for Shallow Tube Well Irrigation Project (STWIP) is not possible and feasible due to deep aquifer and the absence of ready water source for open well irrigation project;

WHEREAS, to make the project feasible for the greater benefit of recipients and to ensure that loan proceeds is utilized efficiently and effectively, amendment of the submitted lists is necessary;
