RESOLUTION NO. 305-2020

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2020 OF MANAOAG, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P200,000,000.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Annual Budget for Calendar Year 2020 involving total appropriations of **P200,000,000.00** which was approved on November 26, 2019 through Appropriation Ordinance No. 02;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007;
2. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;

3. The projects funded under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DILG and DBM JMC No. 2017-1 dated February 22, 2017 re “Updated Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects” and DILG Memorandum Circular No. 2010-138 dated December 2, 2010 entitled “Use of the 20% Component of the Annual Internal Revenue Allotment Shares”;
4. The grant of step increment to some municipal employees and elective officials shall be in accordance with CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016. It is reiterated that in its previous year finding, the step increment of Johayli B. Millare, Librarian I, under the Office of the Sangguniang Bayan shall be adjusted from SG-10/7 P209,460.00 per annum to SG-10/7 P218,352.00 per annum; *and*
5. The appropriation for Representation and Transportation Allowance (RATA) under the Office of the Municipal Treasurer shall be adjusted from P291,600.00 to P270,000.00 per annum and should not exceed the rates authorized under Local Budget Circular No. 103 of the Department of Budget and Management dated May 15, 2013.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality and shall notify the offices concerned of the actions taken thereon;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –


RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Annual Budget for Calendar Year 2020 of Manaog, Pangasinan** as of January 1 to December 31, 2020; subject to posting requirement under Section 59 of RA 7160; and provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Manaog;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Manaog, Pangasinan, for its information and guidance.
