**DECLARING RESOLUTION NO. 158-2017 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "AFFIRMING THE INTEREST OF THE MUNICIPALITY OF AGNO, PROVINCE OF PANGASINAN, TO APPLY, NEGOTIATE AND BORROW FUNDS FROM THE MUNICIPAL DEVELOPMENT FUND OFFICE (MDFO) OF THE DEPARTMENT OF FINANCE (DOF) FOR THE IMPLEMENTATION OF THE FOLLOWING PROJECTS: 1) IMPROVEMENT OF FARM-TO-MARKET ROADS, AND 2) INSTALLATION OF INTEGRATED BUSINESS PERMITS AND LICENSES SYSTEM (BPLS) AND REAL PROPERTY TAX SYSTEM (RPTS) DATA COMPUTERIZATION/ONE-STOP-SHOP SYSTEM" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**
