PROVINCIAL RESOLUTION NO. 309-2021

URGING THE DEPARTMENT OF TRANSPORTATION (DOTr) THROUGH THE LAND TRANSPORTATION, FRANCHISING AND REGULATORY BOARD (LTFRB) TO FAST-TRACK THE PROCESSING OF INTER-REGIONAL/PROVINCIAL TRANSPORT PERMIT FOR PROVINCIAL TRANSPORT OPERATIONS IN THE PROVINCE OF PANGASINAN

WHEREAS, the Land Transportation Franchising and Regulatory Board (LTFRB) is an agency of the Department of Transportation (DOTr) which is mandated to regulate land-based public transportation, and to safeguard the welfare and interests of the commuting public;

WHEREAS, the Provincial Government of Pangasinan, through a letter of the Provincial Governor dated December 29, 2020, has recommended to the LTFRB Regional Office for the resumption of the operations of provincial buses in the Province;

WHEREAS, the Sangguniang Panlalawigan in its mandate as the legislative body of the Province has invited the Regional Director of the LTFRB on its March 8, 2020 Regular Session to shed light on the possibility of the reopening of transportation services particularly interprovincial buses in Pangasinan

WHEREAS, the Sangguniang Panlalawigan has been informed by the good Regional Director that they are still awaiting approval of the inter-regional/provincial transport permit for provincial buses from the LTFRB national office;

WHEREAS, the Sangguniang Panlalawigan fully supports the reopening of provincial buses operations in the Province of Pangasinan subject to the strict implementation of health and safety protocols duly approved by the national and provincial IATF and other policies needed for the imposition of the same;
