APPROVING RESOLUTION NO. 2022-436 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED, "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 02 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN FOR CALENDAR YEAR 2022, REQUIRING A TOTAL FUNDING OF SIXTY FOUR MILLION THREE HUNDRED FORTY THREE THOUSAND TWO HUNDRED TWENTY SIX PESOS (P64,343,226.00)"

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2022-436 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Municipal Development Council of Sta. Barbara, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 2 CY 2022. This was endorsed by the Council, through MDC Resolution No. 04, Series of 2022, dated January 10, 2022 to the Sangguniang Bayan for approval;

WHEREAS, said Supplemental Investment Program (SIP) which has a total investment requirement of (P64,343,226.00), covers agri/infrastructure support for tobacco farmers of the municipality. The identified projects, which will be sourced from the Burley and Native Tobacco Excise Tax Share of the LGU, conform with Local Budget Memorandum No. 84 dated November 22, 2021 of the DBM;
