#### **RESOLUTION NO. 317-2021**

DECLARING MUNICIPAL ORDINANCE NO. 002-2021 OF THE **BAYAN** MALASIQUI, PANGASINAN, SANGGUNIANG **OF** ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY INSTALLATION OF ROAD WARNING AND SAFETY DEVICES (RWSDs) BY ALL CONTRACTORS AND PUBLIC UTILITY ON ALL ON-GOING ROAD AND BRIDGE CONSTRUCTIONS AND **MAINTENANCE ALONG** THE NATIONAL, PROVINCIAL, MUNICIPAL AND **BARANGAY ROADS** WITHIN JURISDICTION OF THE MUNICIPALITY OF MALASIQUI, AND THEREOF" **PROVIDING PENALTIES** AS CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO **ENACT** 

**WHEREAS**, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Municipal Ordinance No. 002-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (viii) and (5) (v) of RA 7160; and DPWH Department Order No. 135, S-2015;

**WHEREAS**, however, the Sanggunian shall comply with the observation of the Provincial Legal Officer on Section 6.6 of the subject ordinance;

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 002-2021 of the Sangguniang Bayan of **Malasiqui**, Pangasinan, entitled "An Ordinance requiring the mandatory installation of Road Warning and Safety Devices (RWSDs) by all contractors and public utility on all ongoing road and bridge constructions and maintenance along the national, provincial, municipal and barangay roads within the jurisdiction of the Municipality of Malasiqui, and providing penalties thereof" as within the conferred powers of the Sangguniang Bayan to enact;
