RESOLUTION NO. 320-2019

DECLARING ORDINANCE NO. 04, S-2018 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "AN ORDINANCE SETTING FOR DISCIPLINARY HOURS IN BANI, PANGASINAN FOR MINORS FROM 10:00 P.M. TO 5:00 A.M., PROVIDING PENALTIES FOR PARENT/GUARDIAN, FOR VIOLATION THEREOF AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Ordinance No. 04, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 17 (b) (2) (iii), (iv) and Section 447 (a) (5) (xiv) of RA 7160; Section 3 (2) Article XV of the Philippine Constitution; Section 2 of RA 7610 (Special Protection of Children Against Abuse, Exploitation and Discrimination Act) and Presidential Decree No. 603 (Child and Youth Welfare Code);

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with all the legal requirements set forth in RA 7160;
