APPROVING RESOLUTION NO. 2021-178 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED, "ADOPTING THE SUPPLEMENTAL INVESTMENT PLAN NO. 2021-04 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2021-178 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the Local Development Council of Binalonan, Pangasinan had identified items in their Supplemental Annual Investment Program No. 4 CY 2021. This was endorsed by the Council, through MDC Resolution No. 2021-04 dated December 17, 2021 to the Sangguniang Bayan for approval;

WHEREAS, the Supplemental Annual Investment Program No. 4 of the municipality covers fund augmentation for Personal Services of the University of Eastern Pangasinan;
