**DECLARING MUNICIPAL ORDINANCE NO. 01, S-2019 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING ARTICLE OF THE MUNICIPAL ORDINANCE NO. 02, S-2017 ENTITLED “AN ORDINANCE DECLARING FIRST SATURDAY OF LENT AND EVERY YEAR THEREAFTER AS “ASIN FESTIVAL” IN THE MUNICIPALITY OF DASOL, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Dasol, Pangasinan submitted its Municipal Ordinance No. 01, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, and the Provincial Planning and Development Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (5) (1) of RA 7160;
