DECLARING MUNICIPAL ORDINANCE NO. 12, S-2019 OF OF **SANGGUNIANG** BAYAN AGUILAR, "AN PANGASINAN, **ORDINANCE** ENTITLED ABOLISHING THE VARIOUS PLANTILLA POSITION AND UNDER **EXECUTIVE LEGISLATIVE** DEPARTMENT OF THE MUNICIPAL GOVERNMENT OF AGUILAR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
