APPROVING MUNICIPAL RESOLUTION NO. 05, S-2019 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE REPROGRAMMING IN THE AMOUNT OF EIGHTEEN MILLION (P18,000,000.00) EARLIER ALLOCATED FOR THE CONSTRUCTION OF TWO STOREY PUBLIC MARKET WITH SKYROOF FROM THE 20% DEVELOPMENT FUND FY 2019 ALONG WITH THE CORRESPONDING AIP"

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Municipal Resolution No. 05, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said municipal resolution and found out that the proposal for reprogramming emanated from the Local Development Council of Aguilar, Pangasinan thru MDC Resolution No. 2, S-2019. This was endorsed to the Sangguniang Bayan for approval on February 4, 2019 and was favorably acted upon by the Sangguniang Bayan on March 11, 2019 thru SB Resolution No. 05, S-2019;

WHEREAS, the funds to be reprogrammed amounting to P18,000,000.00 is earlier allocated for the Construction of Two Storey Public Market with Skyroof funded from the 20% Development Fund FY 2019 and incorporated in the approved 2019 AIP;
