ENDORSING THE APPROVAL OF THE NEW CEMENT PRODUCTION PROJECT (LINES A AND B) OF THE SAN MIGUEL NORTHERN CEMENT, INC. (SMNCI) WITHIN THE EXISTING CEMENT PLANT OF THE NORTHERN CEMENT CORPORATION AT BARANGAY LABAYUG, SISON, PANGASINAN

WHEREAS, the San Miguel Northern Cement, Inc. (SMNCI) through Ms. Rodelia S. Sarrosa, AVP and Support Group Manager, requested the Sangguniang Panlalawigan for a favorable endorsement of the New Cement Production Project (Lines A and B) of the corporation;

WHEREAS, the project involves the construction, design, and operation of an integrated cement plant in Barangay Labayug, Sison, Pangasinan within the existing plant of the Northern Cement Corporation;
