**RESOLUTION NO. 345-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 006-2017 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "AN ORDINANCE OTHERWISE KNOWN AS THE REVENUE CODE OF THE MUNICIPALITY OF MALASIQUI, PROVINCE OF PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Municipal Ordinance No. 006-2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer and the Provincial Treasurer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 129 and 132 of RA 7160;

**WHEREAS**, however, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer stated in her opinion dated March 21, 2019 (which were not yet addressed by the Sangguniang Bayan), as attached in this Resolution;

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of public hearing, posting and publication pursuant to RA 7160;


