DECLARING MUNICIPAL ORDINANCE NO. 103, S-2021 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING ARTICLE IV FLOW OF TRAFFIC AND ARTICLE VIII SECTION 40 REGULATORY ACTS OF MUNICIPAL ORDINANCE NO. 79, SERIES OF 2019 ENTITLED AS THE TRAFFIC CODE OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN 2018 AS AMENDED" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
