#### **RESOLUTION NO. 352-2019**

DECLARING ORDINANCE NO. 02-2019 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE 20,000 SQ. M. LOT OWNED BY HIND SUGAR COMPANY, INCORPORATED LOCATED AT BARANGAY BARITAO, MANAOAG, PANGASINAN FROM AGRICULTURAL LOT TO INSTITUTIONAL LOT PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Ordinance No. 02-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer and the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 of RA 7160;

**WHEREAS**, however, the Sangguniang Bayan shall consider the observations raised by the Provincial Planning and Development Officer in her opinion dated March 8, 2019 in compliance with Memorandum Circular No. 54, Section 2 (b), and the Provincial Legal Officer in her opinion dated March 7, 2019, both as attached in this Resolution;
