STRONGLY ENDORSING TO THE SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS THE CONVERSION OF THE MANAOAG-POZORRUBIO (PAO-POZORRUBIO SECTION) AND SAN JACINTO-POZORRUBIO PROVINCIAL ROADLINES INTO NATIONAL ROADS

WHEREAS, the Manaoag-Pozorrubio (Pao-Pozorrubio Section) and San Jacinto-Pozorrubio Provincial Roadlines with total lengths of 7.65 kilometers and 9.50 kilometers, respectively, are vital arteries connecting central and eastern portions of Pangasinan;




