PROVINCIAL RESOLUTION NO. 373-2021

URGING THE CONGRESS OF THE PHILIPPINES THROUGH THE COMMITTEE ON HEALTH TO CAUSE THE GRANTING OF SECURITY OF SERVICE/TENURE TO QUALIFIED BARANGAY HEALTH WORKERS OF THE COUNTRY

WHEREAS, barangay health workers play important roles in rendering primary health care services needed by the people in the community;

WHEREAS, during this period of pandemic, barangay health workers are also considered as frontliners because they are helping to contain the spread of Covid-19 virus;

WHEREAS, RA 7883 or the Barangay Health Workers' Benefits and Incentives Act of 1995 which provides benefits and incentives to the barangay health workers does not have a provision granting security of tenure to them;

WHEREAS, the granting of security of tenure to qualified barangay health workers nationwide will be an act of recognition to their continuous services and sacrifices to the people;

WHEREAS, with the grant of security of tenure, barangay health workers cannot just be unjustifiably removed from office without due process;

WHEREAS, there is a need to amend Republic Act 7883 by granting security of tenure to barangay health workers in recognition of their selfless and tireless efforts at the community even they are just receiving meager allowances;


