**RESOLUTION NO. 384-2020**

**DECLARING ORDINANCE NO. 07-2020 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “AN ORDINANCE CREATING PLANTILLA POSITIONS UNDER THE MUNICIPAL AGRICULTURE OFFICE; SENIOR AQUACULTURIST, SALARY GRADE 18, AND ADMINISTRATIVE AIDE II (MESSENGER), SALARY GRADE 2” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 07-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of RA 7160;

**WHEREAS**, however, the position of Aquaculturist, SG-18 should be appropriated in a Supplemental Budget of the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 07-2020 of the Sangguniang Bayan of **Sual**, Pangasinan, entitled “An Ordinance creating plantilla positions under the Municipal Agriculture Office; Senior Aquaculturist, Salary Grade 18, and Administrative Aide II (Messenger), Salary Grade 2” as within the conferred powers of the Sangguniang Bayan to enact;
