DECLARING ORDINANCE NO. 21-2020 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “AN ORDINANCE CREATING PLANTILLA POSITIONS UNDER THE PRIMARY CARE FACILITY-MUNICIPAL HEALTH OFFICE (PCF-MHO): MEDICAL OFFICER V, SALARY GRADE 22; MEDICAL OFFICER IV, SALARY GRADE 20; FOUR (4) NURSE 1, SALARY GRADE 11, MEDICAL TECHNOLOGIST, SALARY GRADE 11; PHARMACIST, SALARY GRADE 11, AND ADMINISTRATIVE OFFICER 1 (CASHIER 1), SALARY GRADE 10” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 21-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of RA 7160;

WHEREAS, however, the following observations of the Local Finance Committee should be complied with:

1. The salary grade allocation of the following positions should be adjusted to conform with the provisions of Budget Circular No. 2009-92 dated September 3, 2009, Annex “B” – Re allocated classes of positions:
