PROVINCIAL RESOLUTION NO. 391-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A PARTNERSHIP AGREEMENT WITH THE PHILIPPINE COMMISSION ON WOMEN FOR THE GENDER AND DEVELOPMENT (GAD) LOCAL LEARNING HUB OF THE PROVINCE OF PANGASINAN

WHEREAS, Section 36, Chapter VI of RA 9710, otherwise known as “Magna Carta of Women” provides that local government units shall adopt gender mainstreaming as a strategy to promote women’s human rights and eliminate gender discrimination in their systems, structures, policies, programs, processes and procedures;

WHEREAS, the Gender and Development (GAD) Local Learning Hub aims to showcase innovative GAD structures, processes and programs that can be sustained and improved by local government units;

WHEREAS, the Philippine Commission on Women (PCW) has certified the Pangasinan Crisis Intervention Center (PCIC) as Gender and Development (GAD) Local Learning Hub (LLH) in recognition of the efforts of the Province in empowering women and providing programs promoting gender equality;

WHEREAS, the PCIC is located within the Provincial Social Welfare and Development Office compound as a “temporary shelter” that caters to victims and survivors of gender-based violence;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to enter into and sign a Partnership Agreement with the PCW to further sustain the implementation of certified GAD programs and operationalize the provision of technical assistance to other local government units and institutions;



NOW, THEREFORE, on motion of SP Member Rosary Gracia P. Perez-Tababa, duly seconded, it was –


