RESOLUTION NO. 392-2020

DECLARING ORDINANCE NO. 22-2020 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY WEARING OF FACE MASK AND STRICT PRACTICE OF PHYSICAL DISTANCING BY ALL PERSONS IN PUBLIC PLACES WITHIN THE MUNICIPALITY OF SUAL, PANGASINAN DURING THE PERIOD OF ENHANCED COMMUNITY QUARANTINE UNTIL LIFTING OF THE DECLARATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 22-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legaal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16, and 447 (a) (1) (iii) of RA 7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks or Other Protective Equipment in Public Places) and Provincial Ordinance No. 235-2020 (An Ordinance Requiring the Mandatory Wearing of Face Masks by all Persons in Public Places Within the Territorial Jurisdiction of the Province of Pangasinan During the Period of Enhanced Community Quarantine and For Any Extension Thereof;

WHEREAS, subject ordinance shall take effect afte the Sangguniang Bayan has complied with the legal requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
