PROVINCIAL RESOLUTION NO. 393-2019

EARNESTLY REQUESTING SENATE PRESIDENT VICENTE C. SOTTO III TO ALLOCATE FUNDS FOR THE REHABILITATION AND UPGRADING OF THE LINGAYEN AIRPORT

WHEREAS, a fully functional Lingayen Airport will not only attract local and foreign tourists and investors but will also serve as a symbol of growth and progress in the Province of Pangasinan;

WHEREAS, it is to the best interest of the Province that immediate rehabilitation and upgrading of the Lingayen Airport be undertaken by proper authorities so it can help strengthen the economy and tourism industry of Pangasinan;




