CERTIFICATION

TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on February 5, 1990, at Lingayen, Pangasinan, the following provincial ordinance was approved:

PROVINCIAL ORDINANCE NO. 03-1990

GUIDELINES FOR THE OPERATION OF SMALL TOWN LOTTERY (STL) IN THE PROVINCE OF PANGASINAN, KNOWN SIMPLY LOTTO

Be it enacted by the Sangguniang Panlalawigan in session assembled that:

- SECTION 1 Minors shall not be allowed either as betters or as collectors.

 Minors are understood to mean those who are below the age of 21.
- SECTION 2 All draws shall be held at any place open to the Public preferably the Public Plaza of the Town where the LOTTO is being operated provided that such Public Place shall not be within the radius of 200 meters from any School, Church or Chapel.
- SECTION 3 The FRANCHISEE shall use the equipment, paraphernalia, forms and receipts prescribed by the PHILIPPINE CHARITY SWEEPSTAKES OFFICE. Tambiolos used shall be transparent and the pingpong balls bearing the numbers 1 to 38 must at all times be used and must be visible to the naked eye.
- SECTION 4 Winners of the prizes for every draw must be paid in cash immediately and in no case beyond 24 hours after announcement of the winning number combinations.
- SECTION 5 For each draw, the gross collections shall be determined and reported out to the Representative/s of the Monitoring Committee assigned to the place where LOTTO is in operation. On the basis of this, the total daily collections shall likewise be determined Report of collections shall be made available to the Monitoring Committee at any time upon demand.
- SECTION 6 The 2% share of the Province from the gross monthly collections shall be remitted every 15th and 30th of each month, provided that if the 15th and the 39th day each month falls on Saturday or Sunday, the remittance shall be made on the next working day.

 1% of the provincial government share shall pertain to the Office of the Governor, and the other 1% shall pertain to the Provincial Board, including the Vice-Governor.
- SECTION 7 All ticket forms shall be authenticated by the Monitoring Committee's Representative/s, who shall be named and designated by the Monitoring Committee.

- SECTION 8 District Offices in the six (6) districts of the Province shall assist the Central Monitoring Committee, members of which shall be appointed by the Provincial Board.
- SECTION 9 No Small Town Lottery or Lotto operator shall be allowed in the Province of Pangasinan without first seeking the approval of the Provincial Board.
- SECTION 10a All the provisions of these guidelines must be strictly complied with, and any violations by the Franchisee of the Guidelines contained herein shall result in the automatic cancellation of the authority granted by the Provincial Board.
 - 10b All provisions of the Execute Order of Her Excellency,
 President Corazon C. Aquino, allowing the operation of LOTTO
 in the Philippines are hereby incorporated as part of these
 GUIDELINES and shall be strictly complied with by the
 FRANCHISEE.
- SECTION 11 Effectivity. This ordinance shall take effect upon approval.
