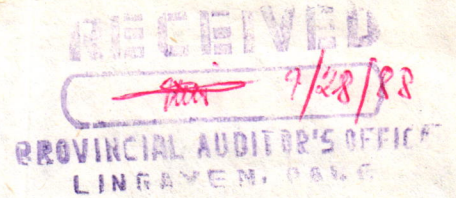
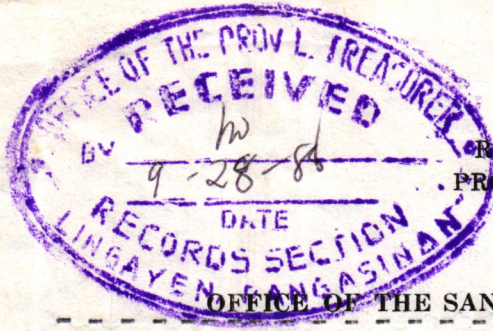

THIS IS TO CERTIFY that at the special session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on August 22, 1988, at Lingayen, Pangasinan, the following Ordinance was approved:

PROVINCIAL ORDINANCE NO. 4

ORDINANCE CREATING SITIOS CABULALAN, BAITO, PIAS, MANGGA, BONZO, AGBAYANI, AGUINALDO, GARCIA, APOLED, DIAZ AND FERNANDEZ OF BARANGAY POBLACION, SUAL, PANGASINAN INTO A NEW DISTINCT SEPARATE AND INDEPENDENT BARANGAY TO BE NAMED "BARANGAY POBLACION EAST"

WHEREAS, this Body is in receipt of Resolution No. 98, s-1987, of the Sangguniang Bayan of Sual, Pangasinan, requesting this Body to favorably on the clamor of the 1,004 residents of Sitios Cabulalaan, Baito, Pias, Mangga, Bonzo, Agbayani, Aguinaldo, Garcia, Apoled, Diaz and Fernandez Poblacion, Sual, Pangasinan to create a new distinct, separate and independent barangay to be named Barangay Poblacion East pursuant to Sections 82 and 83 of the New Local Government Code;

WHEREAS, pursuant to the pertinent provisions of the New Local Government Code in the creation of new barangays, all the requirements therein are satisfactorily met;

WHEREAS, the residents and local leaders therein are of the firm belief that the creation would hasten and exercise social, economic and political development in the area and foster faster delivery of basic services;

NOW, THEREFORE, in view of the foregoing, on motion of Board Member Romualdo G. de Leon, duly seconded by Board Member Luis E. Serafica, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to create, as it hereby created Sitios of Cabulalaan, Baito, Pias, Mangga, Bonzo, Agbayani, Aguinaldo, Garcia, Apoled, Diaz and Fernandez, into a new, distinct, separate and independent barangay to be named "Barangay Poblacion East";

RESOLVED, FURTHER, to request the COMELEC to schedule the holding of plebiscite in this new created barangay within 45 days from the approval of this Ordinance;

RESOLVED, FURTHERMORE, that the Provincial Assessor, in coordination with other agencies, determine the official boundaries of this newly created barangay;




