PROVINCIAL RESOLUTION NO. 406-2021

INVITING THE PROVINCIAL HEALTH OFFICER, PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER AND THE PROVINCIAL DIRECTOR OF THE PHILIPPINE NATIONAL POLICE TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS MAY 3, 2021 REGULAR (PHYSICAL) SESSION TO UPDATE THE BODY ON THE STATUS OF COVID-19 CASES IN THE PROVINCE OF PANGASINAN

WHEREAS, the Province of Pangasinan is now experiencing a steady increase in the number of COVID-19 cases;

WHEREAS, this prompted the Sangguniang Panlalawigan to schedule again a Question Hour and invite the Members of the Provincial Inter-Agency Task Force (IATF) to shed light on the current situation of COVID-19 cases in the Province;

WHEREAS, it is the request of the Sangguniang Panlalawigan to be updated on the health and safety protocols being implemented in the Province more particularly on the mechanics of contact tracing, border control checkpoints and swab testing;

WHEREAS, the Sangguniang Panlalawigan, in collaboration with the Provincial Inter-Agency Task Force, will continue to look for ways and means to enact and pass legislative measures to combat COVID-19;

WHEREAS, the invitation is just a series of Question Hours being conducted by the Sangguniang Panlalawigan in order to gather needed information for effective legislation;


