PROVINCIAL RESOLUTION NO. 407-2019

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERTAKING WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT REGIONAL OFFICE FOR THE ESTABLISHMENT OF A PESO EMPLOYMENT INFORMATION SYSTEM (PEIS) IN THE PROVINCE

WHEREAS, the establishment of the PESO Employment Information System (PEIS) is a project of the Department of Labor and Employment (DOLE) under the National Skills Registration Program (NSRP) which aims to improve facilitation services and provide ready access of labor market information;

WHEREAS, the PEIS is a database of manpower supply which shall be established in the Province that contains profiles, qualifications and skills of applicants and employers registered under the system;

WHEREAS, the Sangguniang Panlalawigan is supportive of the project as it can facilitate and provide fast and effective employment services to the people of Pangasinan, especially jobseekers;

WHEREAS, the duties and responsibilities of the parties including the miscellaneous provisions in the establishment of the PEIS are already defined in the Memorandum of Undertaking;

WHEREAS, for this purpose, a Memorandum of Undertaking shall be entered into and signed between the Province of Pangasinan, represented by Honorable Governor Amado I. Espino III, and the Department of Labor and Employment, represented by Regional Director Nathaniel V. Lacambra;
