THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on October 28, 1994 at Lingayen, Pangasinan, the following Provincial Ordinance was approved:

PROVINCIAL ORDINANCE NO. 41

AN ORDINANCE AMENDING PROVINCIAL ORDINANCE NO. 26, SERIES OF 1993, ENTITLED "GRANTING AN EXCLUSIVE FRANCHISE TO GULF CABLE 2000 TO INSTALL, OPERATE AND MAINTAIN A CABLE TELEVISION SYSTEM (CATV) IN MUNICIPALITY OF LINGAYEN, PANGASINAN AND FOR OTHER PURPOSES"

WHEREAS, the Sangguniang Panlalawigan has approved Provincial Ordinance No. 26, granting an exclusive franchise to Gulf Cable 2000 to install, operate and maintain a Cable Television System (CATV) in Lingayen, Pangasinan on September 24, 1993;

WHEREAS, the Pangasinan Education Cable TV, Inc., has applied to operate, establish and maintain a CATV, also, in Lingayen, Pangasinan;

WHEREAS, after a series of study and evaluation of the Committee on Rules, Law and Justice on the matter of the application of Pangasinan Educational Cable TV, Inc., the said Committee under Committee Report No. 25 recommends that Provincial Ordinance No. 26 be amended so that the word "exclusive" shall be changed to "non-exclusive" in the title and Section 1 thereof;

NOW, THEREFORE, in view of the foregoing, on motion of SP Member Dionisio C. Antiniw, duly seconded, it was -

Be it enacted by the Sangguniang Panlalawigan in session assembled that:

SECTION 1. The title of Provincial Ordinance No. 26 shall be read as follows:

AN ORDINANCE GRANTING A NON-EXCLUSIVE FRANCHISE TO GULF CABLE 2000 TO INSTALL, OPERATE AND MAINTAIN A CABLE TELEVISION SYSTEM (CATV) IN THE MUNICIPALITY OF LINGAYEN, PROVINCE OF PANGASINAN AND FOR OTHER PURPOSES

SECTION 2. Section 1 of Provincial Ordinance No. 26 shall be read as follows:

"For a period of fifteen (15) years from the approval of this Ordinance, GULF CABLE 2000/BIENVENIDO QUINTO, a single proprietorship doing business under the trade name GULF CABLE 2000, its successors or assigns, is hereby granted the non-exclusive right, privilege and authority to install, operate and maintain a cable television system (CATV) in the Municipality of Lingayen, Province of Pangasinan, subject to the following terms and conditions, x x x.";

SECTION 3. EFFECTIVITY. This Ordinance shall take effect upon its approval.
