DECLARING RESOLUTION NO. 119, S-2019 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "ADOPTING AND LOCALIZING THE GENDER AND DEVELOPMENT (GAD) CODE AND THE CHILDREN'S CODE OF THE PROVINCE FOR THE MUNICIPALITY OF BINMALEY, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 119, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said resolution and found out that the same was enacted pursuant to the Gender and Development Code of the Philippines; RA 7192 (An Act Promoting the Integration of Woman as Full and Equal Partners of Men in Development and Nation Building and For Other Purposes); RA 9710 (Magna Carta of Women); United Nations Convention on the Rights of the Child; Presidential Decree No. 603 (The Child and Youth Welfare Code); RA 7610 of 1992 (Special Protection of Children Against Abuse, Exploitation and Discrimination Act); and Section 17 (a) (2) (iv), and (a) (2) (iii) (iv) and Section 447 (a) (5) (xiv) of RA 7160;
