APPROVING RESOLUTION NO. 17, S-2019 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 FOR FY 2019 OF THE MUNICIPALITY OF BUGALLON, PANGASINAN AMOUNTING TO THREE MILLION SEVEN HUNDRED THIRTY SIX THOUSAND FIVE HUNDRED EIGHTY FOUR PESOS AND NINETY SEVEN CENTAVOS (P3,736,584.97)"

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 17, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bugallon, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2019. This was endorsed to the Sangguniang Bayan for approval on April 4, 2019 thru MDC Resolution No. 02, S-2019 and was favorably acted upon by the Sangguniang Bayan on May 21, 2019 thru SB Resolution No. 17, S-2019;

WHEREAS, the Supplemental Investment Program No. 2 of the municipality covers the fund augmentation for the Personal Services and Maintenance and Other Operating Expenses of various municipal offices and implementation of development projects of the LGU;
