APPROVING RESOLUTION NO. 20, S-2019 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "APPROVING THE MEDIUM TERM LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) FOR CY 2016-2022 OF THE MUNICIPALITY OF BUGALLON, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 20, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bugallon, Pangasinan had amended its Local Development Investment Program CYs 2016-2022. This was endorsed to the Sangguniang Bayan for approval on June 6, 2019 thru MDC Resolution No. 03, S-2019 and was favorably acted upon by the Sangguniang Bayan on June 11, 2019 thru Resolution No. 20, S-2019;

**WHEREAS,** the Local Development Investment Program of the municipality was revised to include new projects proposed to be funded from the Local Government Support Fund – Assistance to Municipalities (LGSF-AM) of the Department of the Interior and Local Government for implementation in CY 2020;
