APPROVING RESOLUTION NO. 2021-450 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE MUNICIPALITY'S REVISED ANNUAL INVESTMENT PROGRAM FOR THE CALENDAR YEAR 2021"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its SB Resolution No. 2021-450 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said SB Resolution and found out that the Local Disaster Risk and Management Council of Balungao, Pangasinan through MDRRMC Resolution No. 202101 dated March 10, 2021, has identified priority programs/projects to be funded from the unexpended balances of Municipal Disaster Risk Reduction Management Fund CY 2020 to be included in the 2021 Revised AIP of the municipality;

WHEREAS, the Local Development Council has revised the CY 2021 Annual Investment Program to include the LDRRM programs and projects in response to COVID-19 pandemic which will be funded from the 2020 unexpended DRRMF amounting to Php6,215,722.97. This was endorsed to the Sangguniang Bayan through MDC Resolution No. 2021-01 dated March 16, 2021;


