## **RESOLUTION NO. 427-2019**

DECLARING ORDINANCE NO. 2019-124 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN. ENTITLED "AN **ORDINANCE** INSTITUTING MEASURES TO COUNTERACT BULLYING **COMMITTED AMONG ELEMENTARY PUPILS, HIGH STUDENTS** SCHOOL AND COLLEGE IN THE MUNICIPALITY OF MANGALDAN, PROVINCE OF **PANGASINAN OF 2019" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT** 

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Ordinance No. 2019-124 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 3 (2) Article XV of the Philippine Constitution; Department of Education Order No. 40, S-2012, also known as Child Protection Policy; RA 10627, also known as the Ani-Bullying Act of 2013; United Nations Convention of the Right of the Child and Section 17 (b) (2) (iii) (iv) of RA 7160;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject ordinance in order;
