APPROVING RESOLUTION NO. 2019-58 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PLAN 2019 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2019-58 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Disaster Risk Reduction and Management Council of Mangaldan endorsed through MDRRMC Resolution No. 01-2019 dated February 4, 2019 to the Sangguniang Bayan for approval, the revision of their Annual Development Plan for CY 2019, to include additional priority projects to be funded from the unexpended balances of Municipal DRRM Fund for CY 2018 and prior years amounting to a total of P8,622,762,.52;

WHEREAS, the Municipal Development Council prepared the Revised Annual Investment Plan (AIP) for CY 2019 and endorsed the same thru MDC Resolution No. 3-2019 dated March 25, 2019 to the Sangguniang Bayan for approval. This is in compliance to Item 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1;
