PROVINCIAL RESOLUTION NO. 430-2020

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO MEMORANDA OF AGREEMENT WITH THE PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE OF THE DEPARMENT OF ENVIRONMENT AND NATURAL RESOURCES – REGION I FOR THE ESTABLISHMENT OF MODEL AGROFORESTRY FARMS IN THE MUNICIPALITIES OF UMINGAN, BUGALLON AND MABINI, ALL IN THE PROVINCE OF PANGASINAN

WHEREAS, the national government through the Department of Environment and Natural Resources has called on local government units to collaborate and unify efforts towards natural resources development and environmental management to enhance the greening program of the country through the Enhanced Natural Greening Program;

WHEREAS, the Province of Pangasinan which has rich and vast natural resources has signified its intention to lead and to be actively involved in the rehabilitation, maintenance and protection of identified upland areas;

WHEREAS, the Department of Environment and Natural Resources – Provincial Environment and Natural Resources Office (DENR-PENRO) has identified three (3) municipalities for the possible sites and its corresponding allocation areas for the implementation of the program vis-à-vis establishment of a model agroforestry farm, as follows:

1. Waeg Pamayor, Calitlitan, Umingan, Pangasinan

50.00 hectares

2. Barangay Cayanga, Bugallon, Pangasinan

100.00 hectares

3. Sitio Mapitpit, Brgy. Villacorta, Mabini, Pangasinan

10.00 hectares

WHEREAS, the establishment of agroforestry farms in the identified areas are beneficial to the Province as it will serve as educational and training centers that will help to increaser farmer's incomes, promote conservation and stabilize watersheds, including climate change mitigation and adaptation;

Gayo;
