APPROVING RESOLUTION NO. 13-2022 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 01 FOR THE CALENDAR YEAR 2022 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its SB Resolution No. 13-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Burgos, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on February 02, 2022 by the Municipal Development Council through MDC Resolution No. 2022-01.

2. The Supplemental Investment Program No. 1 of the municipality covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and implementation of development projects and disaster risk reduction programs/activities.
3. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 01-2022 in the amount of P18,223,500.00, which was enacted by their Sangguniang Bayan on February 9, 2022 through Appropriation Ordinance No. 01, Series of 2022 of the Municipality of Burgos.
4. The said Supplemental Investment Program also includes new disaster risk reduction project which will be funded from the reprogrammed 2022 LDRRM project. This was embodied in the Revised LDRRMF Investment Plan CY 2022 and endorsed by the Local Disaster Risk Reduction and Management Council through Resolution No. 2022-01 of the Municipality of Burgos.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Burgos, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 13-2022 of the Sangguniang Bayan of Burgos, Pangasinan, entitled “Approving Supplemental Annual Investment Program No. 01 for the Calendar Year 2022 of the Municipality of Burgos, Province of Pangasinan”;
