RESOLUTION NO. 434-2019

DECLARING MUNICIPAL ORDINANCE NO. 2019-02 OF SANGGUNIANG THE BAYAN OF **BINALONAN**, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING ALL COMMERCIAL AND BUSINESS ESTABLISHMENTS IN THE MUNICIPALITY OF BINALONAN, PANGASINAN TO EXTEND JOB OPPORTUNITIES TO QUALIFIED SENIOR CITIZENS AND PERSONS WITH DISABILITY" AS WITHIN THE CONFERRED **POWERS** OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2019-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Article II, Section 9 of the Philippine Constitution; RA 9994 (An Act Granting Additional Benefits and Privileges to Senior Citizens, Further Amending RA 7432, otherwise known as An Act to Maximize the Contribution of Senior Citizens to Nation Building, Grant Benefits and Special Privileges and For Other Purposes); RA 10524 (An Act Expanding the Positions Reserved for Persons with Disability, Amending for the Purpose RA 7277, otherwise known as the Magna Carta for Persons with Disability); and Sections 17 (b) (2) (iv) and 447 (a) (1) (iii), (6) of RA 7160;

> **WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication pursuant to the provision of RA 7160;

> WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

> **RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2019-02 of the Sangguniang Bayan of **Binalonan**, Pangasinan, entitled "An Ordinance requiring all commercial and business establishments in the Municipality of Binalonan, Pangasinan to extend job opportunities to qualified senior citizens and persons with disability" as within the conferred powers of the Sangguniang Bayan to enact;
