DECLARING ORDINANCE NO. 97, S-2021 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE CREATING SEVERAL PLANTILLA POSITIONS IN THE MUNICIPAL GOVERNMENT OF LINGAYEN AND DEFINING THEIR QUALIFICATIONS, DUTIES AND FUNCTIONS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 97, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76, 447 (a) (1) (viii) and 443 (c) (2) of RA 7160;

WHEREAS, however, the Sangguniang Bayan shall enact an ordinance creating the Municipal Tourism Office since the position of Municipal Government Department Head (Municipal Tourism Officer) is created in the subject ordinance;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was
