RESOLUTION NO. 444-2022

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2022 OF THE CITY OF SAN CARLOS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P1,258,607,859.10, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Annual Budget for Calendar Year 2022 involving total appropriations of P1,258,607,859.10, which was enacted on November 22, 2021 through Appropriation Ordinance No. 21-14 and approved by the City Mayor on December 29, 2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the grant of step increment to some city employees and elective officials shall be in accordance with the CSC-DBM Joint Memorandum No. 1, S-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016;

2. That the appropriation for devolved functions and services in FY 2022 should be provided and shall be in accordance with the provisions of Executive Order No. 138 dated June 1, 2021, DBM-DILG Joint Memorandum Circular No. 2021-1 dated August 11, 2021 and Local Budget Circular No. 145 dated March 2, 2022 and shall be consistent with the Devolution Transition Plan of the City;
3. That the appropriation and disbursement of Terminal Leave Benefits and Monetization of Leave Credits shall be in accordance with Budget Circular No. 2016-2 dated March 29, 2016 re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits which provides for the new constant factor stated under Item 3.1 thereof;
4. That the grant of Hazard Pay to Public Health Workers shall be in accordance with the rates authorized under Implementing Rules and Regulations of R.A No. 7305 (Magna Carta for Public Health Workers);
5. That the disbursement of Magna Carta Benefits of public health workers shall be in accordance with DBM-DOH Joint Memorandum Circular No. 1, s. 2012 dated November 12, 2019 re: Rules and Regulations on the Compensation-Related Magna Carta Benefits to Public Health Workers (PHWs);
6. That the lump sum appropriation for 3rd Tranche Salary Increase shall be in accordance with Local Budget Circular No. 143 dated January 3, 2022 and that a revised plantilla of personnel should be submitted;
7. That the purchase of motor vehicle/s shall be in accordance with Budget Circular No. 2022-1 dated February 11, 2022 (Omnibus Guidelines on the Acquisition, Use, Rental and Replacement of Government Motor Vehicles);
8. That the projects under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020. Re: Revised Guidelines on the Appropriation and Utilization of Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects;
9. That the items funded out of the Local Disaster Risk Reduction and Management fund shall be in accordance with R. A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF), and that 30% shall be set aside as Quick Response Fund;

10. That all procurements to be undertaken shall be subject to the provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
11. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Annual Investment Program of the city formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007; and
12. That the appropriation and disbursement of Election Reserve shall be in accordance with COMELEC Resolution No. 10695 promulgated on February 10, 2021.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the city;

WHEREFORE, in view of the foregoing, motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –


