#### **PROVINCIAL RESOLUTION NO. 445-2019**

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO EXECUTE A DEED OF DONATION IN FAVOR OF THE PHILIPPINE NATIONAL POLICE FOR THE GRANT OF ONE (1) UNIT MOTOR VEHICLE

**WHEREAS**, the Philippine National Police sought the help of the Province of Pangasinan in the acquisition of a motor vehicle that could help them in the augmentation of their capacity to serve the people of Pangasinan;

WHEREAS, a one-unit 6x6 Rescue Truck, under the custody of the Provincial Disaster Risk Reduction and Management Office, is available for donation by the Province to the Pangasinan Police Provincial Office (PPPO);

WHEREAS, the motor vehicle could be used primarily by the PPPO in carrying out its functions and responsibilities, especially during the occurrence of emergency situations, disasters and calamities, not to mention also its daily operations;

WHEREAS, the Sangguniang Panlalawigan expresses its willingness to support the donation in the spirit of cooperation and mutual assistance to bring further peace and harmony in the Province;

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance;
