**RESOLUTION NO. 450-2021**

**DECLARING MUNICIPAL ORDINANCE NO. 102, S-2021 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING THE USE OF KARAOKES, VIDEOKES AND OTHER AMPLIFIED AUDIO SOUND DEVICES WHICH TEND TO DISTURB THE COMMUNITY DURING ONLINE CLASS SCHEDULES FROM MONDAY TO FRIDAY, EIGHT IN THE MORNING UNTIL FIVE IN THE AFTERNOON (8:00 A.M. – 5:00 P.M.) WITHIN THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN AND PROVIDING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 102, Series of 2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447 (a) (1) (iii) and (4) (i) of RA 7160; DILG Memorandum Circular No. 2020-071; Provincial Ordinance No. 242-2020; and the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of April 3, 2020;

**WHEREAS**, subject ordinance shall take effect after the requirements of posting publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;


