**PROVINCIAL RESOLUTION NO. 453-2019**

**INVITING THE PROVINCIAL DIRECTOR OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT AND THE DISTRICT ENGINEERS OF ALL PANGASINAN ENGINEERING DISTRICTS OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO APPEAR BEFORE THE SANGGUNIANG PANLALAWIGAN DURING ITS QUESTION HOUR ON SEPTEMBER 9, 2019 REGULAR SESSION TO APPRISE THE AUGUST BODY ON THE POLICIES RELATIVE TO THE CLEARING OF ROADS OF ILLEGAL STRUCTURES AND CONSTRUCTIONS, IN AID OF LEGISLATION**

**WHEREAS**, pursuant to Department of the Interior and Local Government Memorandum Circular No. 2019-121, dated July 27, 2019, all local officials are enjoined to exercise their powers to reclaim public roads which are being used for private ends and to get rid of illegal structures and constructions;

**WHEREAS**, further, local Sanggunians are enjoined to revisit their ordinances and similar legislative measures to ensure responsiveness to the implementation of the road clearing operations;

**WHEREAS**, there are reports that Department of Public Works and Highways, which plays an important role in the clearing of roads against illegal structures and constructions has already started the implementation of the program in the Province of Pangasinan in coordination with the local government units;

**WHEREAS**, it is the aim of the Sangguniang Panlalawigan to fully respond to the implementation of this directive and therefore there is a need to invite the concerned authorities to enlighten and apprise the Body on the policies being undertaken by them to guide the Sanggunian in the drafting of legislative measures which are consistent with related laws and policies;
