#### PROVINCIAL RESOLUTION NO. 455-2021

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT-I FOR THE TRANSFER OR SUB-ALLOTMENT OF FUNDS TO PANGASINAN MOLECULAR DIAGNOSTIC LABORATORY TO AUGMENT THE OPERATIONS OF COVID-19 TESTING LABORATORIES

**WHEREAS**, the Provincial Government of Pangasinan recognizes the need to maintain the operation of the Pangasinan Molecular Diagnostic Laboratory during this period of public health crisis;

**WHEREAS**, DO No. 2021-0133 of the Department of Health provides for the Guidelines on the Sub-Allotment and Utilization of Funds to the Centers for Health Development for the Procurement of Supplies and Consumables in Response to COVID-19;

**WHEREAS**, the Department of Health is mandated to sub-allot funds in the total amount of P240,000,000.00 to COVID-19 partner laboratories and the Pangasinan Molecular Diagnostic Laboratory is allotted the amount of P5,000,000.00;

**WHEREAS**, the fund shall be used solely for the procurement of supplies, consumables and other COVID-19 testing-related needs for the Pangasinan Molecular Diagnostic Laboratory;

**WHEREAS**, in regard to the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino, III and the Department of Health Center for Health Development-I, represented by Regional Director Valeriano Jesus V. Lopez;
